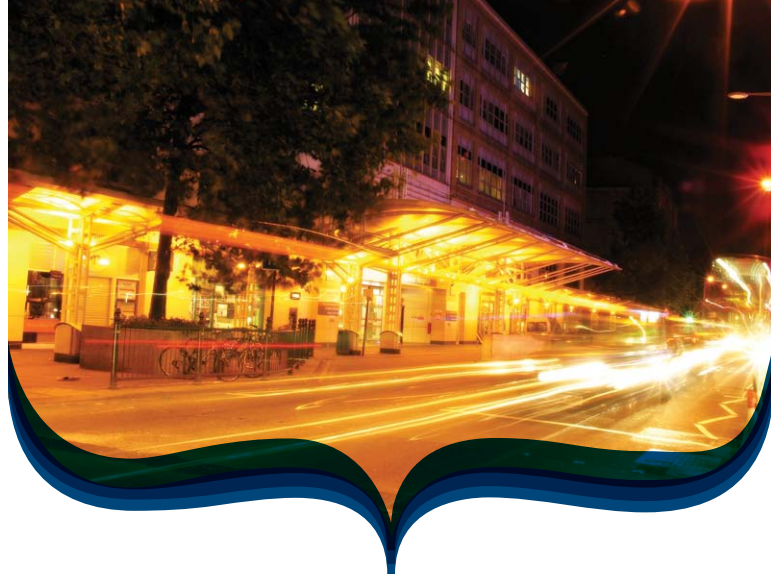

What is scrutiny?

Scrutiny means critical observation and examination. It is essentially the Councillor-led watchdog of services in a particular borough.

Scrutiny committees provide ‘critical friend’ challenges to a Council’s performance in order to improve public services.

They do not just inspect Council decisions, however—they also look at the work and impact of other public service providers such as the NHS and other local health bodies.

This meeting is the second in a series to be hosted by Kensington and Chelsea’s Adult Social Care and Health Scrutiny Committee.

Chelsea and Westminster Hospital NHS Foundation Trust is a hospital primarily based on Fulham Road, but with a network of HIV and sexual health centres elsewhere.

It provides general services for people living in the local area as well as a range of specialist services including children’s and neonatal surgery, children’s A&E, high risk maternity, dermatology and stroke services.

It is also the regional burns unit for London and provides extensive HIV and sexual health services.

The Trust employs more than 3,000 members of staff and treats more than 360,000 patients a year.

Meeting timetable

The meeting will provide an update from the Trust, including its plans to become a ‘major’ hospital as part of work to reorganise the NHS in North West London with 24/7 A&E and associated emergency, surgery, and complex medicine.

Also to be discussed will be the hospital’s performance.

Members of the public and local community groups are invited to attend and there is no need to book.

The meeting will include:

- A presentation by representatives from Chelsea and Westminster Hospital
- A public question and answer session
- A Councillor-led discussion
